FUNDING REQUIREMENTS

In order to be considered for funding, applicants and their applications must meet the following requirements:

- 1. Funding provided by the May Court Club of London must be used to:
 - a. serve children or youth within London
 - b. meet the Vision and Mission of the May Court Club of London as stated above.
- 2. The application must be post marked no later than **March 31**st **5pm** of the given year. Applications and requested documents may be emailed or mailed.
- 3. Successful applicants must be available to receive the funding in person, at The May Court Club of London's Annual General Meeting held on the first Monday in June at approximately 5pm. Each successful applicant will be asked to speak very briefly about their organization and how the funding will be used.
- 4. Successful applicants will need to provide The May Court Club of London with copies or links to all methods used to acknowledge the funding received. Each successful applicant will be required to use the Club's masthead (as shown above) in all promotional items associated with the funding. Public acknowledgement of The May Court Club of London is a requirement of receiving the funding.
- 5. Each successful applicant will be required to submit a post project\program funding report outlining:
 - a. Actual expenditures funded based on the budget submitted with the application.
 - b. How the funding helped children or youth in London. Where possible provide specific numbers of children or youth helped.
 - c. The impact the funding had on helping address specific issues related to children and youth in London.
