#### THE MAY COURT CLUB OF LONDON

#### **VISION STATEMENT**

The May Court Club of London will be the leading women's volunteer organization that provides support for the children and youth in our community.

#### MISSION STATEMENT

The May Court Club of London will nurture and advocate for children and youth in our community who are in need of social, educational, physical, or emotional support.

#### **VALUES**

The May Court members will adhere to the following values of leadership, teamwork, integrity, excellence, compassion and accountability.

#### STATEMENT OF PRINCIPLE

- 1. To provide members of The May Court Club with opportunities to serve the youth of the London community and in so doing achieve personal growth and development through voluntary service.
- 2. To undertake service to the community through the direct delivery of quality programs to children in need and through support to other child serving organizations.
- 3. To undertake fundraising activities that financially support the programs of the Club.
- 4. To allocate resources to support Club programs primarily, and secondly to other organizations as resources are available and for projects/programs where need is clearly demonstrated.

#### STANDING RULES

- 1. Standing Rules are to be reviewed at year-end by the Board, and any re-visions presented to the membership at the AGM for approval.
- 2. Members will be notified in writing of any changes in the Standing Rules prior to the AGM. The revised Standing Rules will be published in the Annual Report.

#### **MEMBERSHIP**

- 3. The Membership Activity Form and dues for the ensuing year shall be in the hands of the Vice-President by June 1st each year.
- 4. Membership fees shall be reviewed by the Board and shall be set to cover the costs of club administration.

- 5. The annual dues for Active and Associate members shall be \$70.00. Honorary and Charter members shall be \$35.00. All dues are payable with the return of the Membership Form. Members who have not paid their dues by June 30th shall be removed from the membership list.
- **6.** Each member is responsible for finding a substitute when she is unable to fulfill her weekly commitments.
- 7. Up to a limit of \$1000.00 may be granted annually to cover expenses for meetings, socials or workshops.

#### NOMINATING COMMITTEE

- 8. Members of the Nominating Committee shall be Active members and not eligible for election to the Board of Directors. A member from each core committee will be chosen to sit on the Nominating Committee following Board approval and will be presented to the membership at the Spring General Meeting.
- 9. The Nominating Committee shall receive suggestions for appointment of members as Convenors, or Assistant Convenors, of Club activities before the end of February. The Nominating Committee will present a list of convenors for Club activities for the upcoming year at a Spring General Meeting.
- **10.** The Nominating Committee shall receive nominations in writing for Directors and Officers until April 30th. A full slate of Officers will be submitted to the Board of Directors for approval at the May or June Board Meeting.

#### **FINANCE**

- 11. The Finance Committee will include the President, Past-President, Treasurer, and two active members.
- 12. The budget will be developed by the Finance Committee for the April Board Meeting and shall be subject to approval by the membership at the May General Meeting.
- 13. All Board Members, Core Directors (excluding Director of Shop) and Convenors who have regular annual expenses for their area of activity shall submit annually to the Board a written projection of expenses for the next fiscal year.
- 14. Third Party requests will be considered if funds are available after the Club's funding and financial needs have been met. The Club will give financial support only to an organization whose purpose is consistent with the Mission of the May Court Club of London.
- 15. All requests for funds received in writing before March 31 will be considered by the Finance Committee. The Finance Committee will submit its recommendations to the Board at its April Meeting. The distribution of funds to third parties will be voted on at the May General Meeting.
- **16.** Any May Court member may submit a request, in writing, by March 31 on behalf of a third party. Requests should include specifics of the organization and the program(s) for which the request is being made.
- 17. Each year a discretionary fund will be established to meet urgent third-party re-quests for nominal amounts (under \$200.00). Only one request per recipient will be considered in any fiscal year.

- 18. As a tribute to a deceased member of the May Court Club of London, a memorial donation shall be made in the amount of \$50.00, to the Memorial Fund, on behalf of the Club. Additional memorial donations, not designated to a specific program, shall be allocated to the Memorial Fund, until such funds are sufficient to fund a special project. The special project will need to be approved by the membership.
- 19. Terms of consignment at the shop will be a 50/50 split between the customer and the Shop.
- 20. Tax receipts may be given in lieu of cash remuneration for articles sold at the shop.
- 21. An annual contribution of \$1000.00 will be made to the Convention Fund in preparation for future Association meetings that we host.

#### **CLUB OPERATIONS**

- 22. To expedite the completion of business, copies of the Minutes of a General Meeting will be distributed electronically to the membership prior to the next General Meeting.
- 23. The Assistant Treasurer and the Assistant Secretary shall be invited by the Board of Directors to attend Board functions and meetings as non-voting members, during the second year of the term of the incumbent Treasurer and Secretary.
- 24. The Club's Special Project activities will be subject to the approval of the membership at a General Meeting. Special Projects are defined as all Club activities other than Nutrition, Shop, Sibling Program, May Court Marketplace, Artisans, Sewing/ Knitting. Members make a voluntary commitment to these special project activities.
- **25.** All members will be requested to promote the May Court Marketplace, and every Special Project that we undertake through the use of flyers and invitations, and all forms of social media.
- **26.** Associate members will be encouraged to stay involved in Club activities and to donate baked goods to the May Court Marketplace Bake Table.
- 27. The Annual Report of The May Court Club of London is not to be used for commercial purposes by members or non-members.
- 28. All soliciting of advertising and/or gifts by members shall be coordinated by the Convenors of the special events.
- **29**. There will be no borrowing of May Court equipment.
- **30.** Association dues are to be paid for all current members on the roster, except for out-of-town members. The Association determines the amount per member to be paid.

#### PLANNING COMMITTEE

- 31. The Board of Directors will be responsible for assessing the viability of the Shop on an annual basis.
- **32.** The Shop Committee shall oversee the operation and maintenance of the Shop building and coordinate the activities of groups utilizing the Shop. They will report to the Board of Directors.
- **33.** The framework for the Club's ongoing participation in the Nutrition Program is established as follows:
- a. That this program be the Club's primary service initiative, receiving funding prior to third party disbursements

- b. That the Club continues to plan and implement its program based on the financial needs of each individual school's nutrition program.
- c. That expansion to new school sites is undertaken only if existing school servicing can be maintained, and if there are sufficient funds within the May Court School Nutrition Program budget.
- 34. The Club assigns to the Director of Communications responsibility to prepare a Community Awareness Plan. This plan should be developed in conjunction with the Board and the Planning Committee and should reflect the research, the identified needs of the Club and the full goals identified in the Strategic Planning Committee Recommendations.
- **35**. The Club assigns to the Vice President responsibility to work with the Board and the Planning Committee to prepare a plan to expand the membership base of the Club.
- **36**. The Past President shall be responsible for a comprehensive review of the Strategic Plan based on an annual review.

#### **PROGRAM COMMITTEE**

**37**. The Vice President shall be responsible for coordinating the program for meetings, and Club activities.

#### SECRETARY'S REPORT

This past year brought some relief from the restrictions of the COVID years. Some activities were restarted and we were able to have some meetings in person. It was a busy year.

The Shop was open during the month of July, and closed in August. It re-opened in early September. Staffing has remained an issue as volunteers were reluctant to come back to the Shop post COVID. This has put a strain on the remaining volunteers who try to substitute as able.

The summer and fall were busy times for the members who make products to sell at the Marketplace. The Knit One Sew Too group, the Artisans and May's Pantry were in full production. Later in the Fall, the frozen foods groups were busy, as were the members who supplied the baking for Marketplace.

Two long standing members passed away in the summer- Dorothy Panabaker and Mary Lynn Mansell. There were memorial donations to May Court and the secretary was kept busy doing thank you notes with tax receipts.

The Annual General Meeting was held on September 12 at Sunningdale Golf and Country Club. This later date was to enable the completed financial statements to be presented and accepted in accordance with accepted practices for charities.

The Board held virtual meetings in September, October and November. In October there was a virtual General Meeting with Sarita Light as the guest speaker on Mind-Body Connection.

November 13 was the Marketplace held at Boler Mountain. This was a new venue and the big windows and helpful staff made it a great event. People enjoyed the food service offered by Boler and the designated area to enjoy the refreshments. We were allowed to set up all the May Court tables and displays on the Saturday afternoon, so that only the outside vendors needed assistance on the Sunday morning before opening. Boler was a two- level facility, but there was elevator access.

December was the cancellation of the Christmas Party due to continued COVID concerns. However, members rallied and donated items for the Glen Cairn Resource Centre, which were gratefully appreciated.

In January there was a Board Meeting on Zoom, and the first in-person general meeting on January 23. This was held at Riverside United Church. The Executive Director of Vanier, Kelly Simpson was the speaker and gave an update on new developments at Vanier.

In March, there was a Virtual Board meeting and the second in-person general meeting on March 27<sup>th</sup>. The speaker was Diana Londono, a beekeeper, who delighted us with so much information about bees. March also had the Artisans have a successful booth at the Western Fair.

April was a busy month as the Associate Sponsorship requests were vetted by the Finance Committee. The Spring Luncheon was held at Boler Mountain on April 18, with 64 members and guests in attendance. The Association President and Secretary were our special guests. The Association Annual General Meeting and members' dinner was held on April 29 in Kitchener.

May 1 was a Virtual Board meeting and May 8<sup>th</sup> was a general meeting held at Chartwell Retirement Home. The Associate Sponsorship Funding requests were presented and approval given for the awards. These organizations received funding: ELUCO, LUSO, LIFESPIN, London Community Chaplaincy, Vanier Children's Services, St. Mark's Anglican Church and Mission Services/ Rotholme.

May also had the successful bake sale at Heemans' on May 20<sup>th</sup>.

In compliance with the new ONCA (Ontario Not for Profit Corporations Act) regulations, a small committee reviewed all the regulations and required changes, and revised our Constitution and Bylaws document. There were 8 drafts of the changes. The proposed changes were presented to the Board and then to the general membership at a special Virtual Meeting May 29<sup>th</sup>. The changes were approved and the new 2023 Bylaws was sent to the government for review.

The final event of the year was the huge Garage Sale held on June 3 at Joan McConnell's. This was the weekend of the Gathering on the Green in Old South and many people came to the sale. It was a great day weather wise and gave our members a chance to work together.

The last requirement for the year will be the submission of reports for the Annual Report.

# ONTARIO NOT-FOR-PROFIT CORPORATIONS ACT (ONCA)

The Ontario Government has a new Not-for-Profit Corporations Act (ONCA) that requires all charities to comply with the same regulations. Our Club was required to review and update the documents that govern our club. The last repeal of our Constitution and Bylaws document was in 2011. This compliance with ONCA gave us an opportunity to revisit everything.

A small committee led by Bev Woode reviewed all the materials and regulations. A series of meetings were held where the proposed changes and compliance were hashed out. It was interesting how 4 people could have different takes on the same sentence. To that end there were 8 drafts of changes done.

The explanation of changes and the revised document was presented to the Board and then to the general membership on May 29<sup>th</sup>. All changes were reviewed and discussed and the final revised 2023 document approved. This was sent to the Government for approval. We hope that what we have modified will be sufficient for compliance.

Of note, many other May Court clubs have engaged lawyers to do this work. Our committee felt that we should do our own revisions and see if it is approved. Thank you to the committee of Bev Woode, Libby McMillan, Cathy Egerton and Jan DeRose for their diligence.

#### TREASURER'S REPORT

**Treasurer: Bev Woode** 

Once again, the firm of **Famme & Co** has prepared **the Review Engagement** of our financial statements for the fiscal year ended May 31, 2023.

Every year "not for profit companies and charities" must obtain an independent review of their financial position including the statements of revenues and expenditures, net assets and cash flow for their fiscal year by a qualified independent accountant. This can be a review engagement or an audit. We have always chosen to do the review engagement.

The review engagement is made in accordance with Canadian generally accepted standards for review engagements and accordingly consists primarily of inquiry, analytical procedures and discussion related to information supplied by the organizations. A review is not an audit and they do not express an audit opinion on the financial statements. A conclusion is always provided, but in a negative form, e.g. nothing has been brought to our attention, that would make us believe these financial statements aren't free of material misstatement.

An audit employs different more in-depth methods to determine if a financial statement is free of any form of material misstatement including evaluation and study of internal controls, making

inquiries, material inspections, and a physical count of assets. An audit strives to corroborate the disclosures and amounts in financial statements by obtaining and performing analytical procedures, audit evidence, observations, conformations, and so on. Opinions are expressed, but in a positive form, e.g. these financial statements are completely free of material misstatement. The auditor involved has to dedicate an ample amount of their time assessing fraud risk and understanding the internal control of your entity. Therefore, an audit is considerably more expensive than a review.

#### MEMBERSHIP REPORT

Using our website to facilitate Membership has been a strong focus in the past few years to improve communication for members and to create greater efficiencies in managing member information. This was done in close partnership with the Strategic IT Committee. Early efforts set the stage for enabling the majority of members to renew their annual membership in June via the portal. Payments online could be completed using Pay Pal, or e-Transfer, although cheques could be submitted for those who still preferring paper renewals.

During 2022- 2023 the membership portal was tweaked further to make it easier for members to Edit/Add their Club Volunteering and Activities. Members were offered one-on-one training if needed. Members were reminded they could now login to their membership profile, from the main website by clicking on the Membership Link. They could then access their profile by using their own unique username and password. Once logged in, the website facilitated a number of choices such as: updating personal information, posting a photo of themselves, accessing the updated membership directory, reviewing the event calendar, and reading the Club's newsletters.

This year the Club consisted of a total of 107 Members. The membership included 86 London Members, 14 Honorary Past Presidents, 9 Out-of-Town Members (of which 2 are Past Presidents), and One Life Time Honorary Member – Patti Frost. (Patti helps keep our membership records straight and our website up-to-date.)

A special thank you was extended to our 14 "Honorary Past Presidents" who continue to be paying members, and a number who are still also very active in the club. These members are vital to the

Club's Spirit. These members include, Karen Blackwell, Irene Dapueto, Jan DeRose Cathy Egerton, Margot Linton, Libby McMillian, Penney McCain, Nancy Poole, Marilyn Rawson, Susan Richardson, Jane Archer Smith, Libby Thomson and Sally Zandri.

The Club is also grateful for its members who have moved out-of-town but who continue to pay dues. These members include Elise Feightner, Gail Williams, Heather Irwin, Madge Witzing, Ruth Brownlee, Penny Anderson, and Susan Hollyman, as well as two Past Presidents Marilyn Rawson, and Susan Richardson.

Recognition of members is sometimes also provided externally. Longtime May Court member Carolyn Scott was honoured at MPP (London West) Peggy Sattler's Community Recognition awards. The event occurred during Sattler's annual New Year's Levee at the Byron Legion on the evening of January 19th 2023. The awards honour "the passion and commitment of London West volunteers who work to make that community a better place." Carolyn was nominated by Club Secretary Jan DeRose and deservedly recognized for her many contributions to May Court and the London Community.

The Club's membership numbers are evidence that membership has indeed declined over the past 10-years, with decline during the pandemic impacting membership further. Members were reminded that a steady supply of volunteers willing to give their most valuable resource (time) is critical to the Club's future. Moreover, the need in our community has never been greater with an increase in London rents by 36% - the highest jump in Canada. We fear many families will be paying rents instead of buying nutritious food.

The Committee encouraged members to speak to friends who may be looking for a way to help London at this time of need, and to ask them to consider becoming a London May Court member. It is important to inform prospective new members that our volunteers are making a difference in our community through The Club's Nutrition Program, Associate Sponsorship Program, Y.O.U. and Glenn Cairn Resource Centre.

Finally, the club would not be able to help the community without its precious volunteers who give their time to support the Club's fundraising activities.

#### PLANNING COMMITTEE REPORTS

#### VISIBILITY COMMITTEE

The Visibility committee continues to look at different ways to increase both our membership and community awareness.

The 50/50 draw, continues to raise funds for the Club every month. Thank you to Maria Wiebenga for her dedication in starting this worthwhile fundraiser this past year. Our Social media is increasing our exposure thanks to the work of our new member Jody Campbell. An informal meeting of members was held in May to discuss ways to increase visibility and membership with many excellent ideas presented. The spring meeting of the Visibility committee was held to discuss the projects for the fall and to have an idea of how we continue to increase our presence in the community. Both the Glen Cairn project of helping with food distribution and Y.O.U. member involvement are ways that make us more visible in our community.

The power point presentation highlighting the good work of May Court has been updated. Please keep us in mind if you have a service club or church group looking for speakers. We have several people who are willing to provide the narrative about the Club. We do, after all, like to talk!

We are always interested in new committee members and ideas to increase awareness of the Club.

#### STRATEGIC IT COMMITTEE

The Membership portal was completed early last year and changes are detailed in the Membership Report also included here. This year, the Club's main website underwent considerable revamping and now leverages the four boxes appearing at the top of the page to engage visitors to the site on the Club's fundraising activities.

The boxes at the *top of the page* will be used to advertise new requests by the Shop, and reminders of the Monthly 50/50 draws which is hyperlinked to RaffleBox for ticket purchases. Some members of The May Court Club of London have indicated an interest in selling the shop and its property. The cost of relocating to a suitable building, at an affordable price, is beyond our financial capabilities at this time.

All of the surrounding properties, with the exception of the one bordering the west, have recently sold to one individual interested in rezoning and building a high-density residential structure. He would need to purchase the May Court building and purchase the laneway access owned by the City of London. So far he has not been successful with City Hall negotiations.

Negotiations between the new owner and the May Court Board of Directors have not resulted in an agreement of sale. In addition, Commercial realtors who have listed the property for sale have not generated other interested buyers.

We will continue to be open to dialogue to sell our property when the conditions are favourable.

There was no other event scheduled at Boler for the Saturday evening which meant that we could bring our products and set up all the May Court tables on Saturday afternoon. This was a must as elevator access was needed to bring our wares upstairs to the second floor. Sunday morning was then reserved for the vendors to arrive and set up.

The day was a tremendous success. The floor to ceiling windows and the fresh snow brought light to all the displays. Boler Food Services offered breakfasts and lunches to the volunteers and guests, and a separate seating area in the old chalet made it easy to enjoy the refreshments. May Court tables on the main floor included the Door, Information Table, Frozen Foods, Door Prize, and Books and Puzzles. The second floor had the Artisans, Sewing and Knitting, May's Pantry, Baking, the Quilt raffle, and the nine vendors. It was a colourful display.

A special feature this year was the "Road Home" Quilt that was sewn and donated by Carol Butcher. This was a raffle item, which necessitated a City Hall license and compliance with all the rules. The winner was thrilled to win it.

Carol was able to secure high school students to volunteer their time to help with set up on Saturday, and Sunday, work at the event and assist customers, and help with the take down of the displays. We could not have done the physical work without them as the books and puzzles and the preserves totally filled a cargo van.

At the last Marketplace before COVID, people were questioned about how they heard about the event. It was mostly social media. This time people commented on all the multiple mediums that we used — billboards, Postcard Portable signs, newspapers, web sites, flyers, Radio ads, and Facebook. #### **SERVICE REPORTS**

#### EXTERNAL BOARD REPRESENTATION REPORT

Vanier Children's Services Representative: Sally Zandri

Vanier Children's Services finally feels that Covid is behind them and it is now "Business as Usual". The model of care has changed to provide a better fit of inclusion for all families. Whether it is a virtual appointment, by video or phone, or an in-person session, the importance of inclusivity is a priority embedded in the work that Vanier undertakes.

This past year Vanier developed their new Strategic Plan for the coming 3-5 years. The Mission statement We deliver culturally responsive, accessible mental health services to children, youth, and families while providing system leadership and advocating to improve care in our community was created after many hours of discussion with stakeholders, families and staff, including the Board. The Vision statement of: A community that cares, supports, and transforms the lives of children and families; demonstrates the future not only of Vanier, but their view of the community.

The Values of *Compassion, Belonging, Advocacy, Trust, Innovation and Excellence* have been established through dedicated work to demonstrate the commitment of the organization and the amazing staff.

Vanier was very fortunate this year to have received funding from the government for several big projects. The 60 year old Vanier building on Trafalgar Street has been given a long overdue new roof. With grant and ministry money the work to replace the roof was started in early spring and will be completed in July. There has been new air conditioning installed to provide a better environment for staff and families. With grants provided, new accessible washrooms have been created.

Many of the programs at Vanier are back to running full throttle, with the Tandem crisis team spending time in the ER at Victoria Children's hospital to assist with diverting patients to a more appropriate mental health treatment in a very timely way. The ER has expressed their gratitude for this program and its success.

HAVEN, a very unique treatment program for children and youth with eating disorders has been created in partnership between LHSC and Vanier. This live-in treatment program is the first of its kind in Ontario and is now experiencing success with some of its first clients. It is anticipated that this program model will be established at other children's mental health facilities in the province.

A very robust telemedicine clinic is provided by psychiatrists working out of Vanier. There are approximately 8-10 physicians attending this clinic to assess and treat children and families from all over the province.

The H.O.P.E. program director, Darlene Wierski-Devoe came to Vanier with many years as a trained peer support facilitator. Her expertise has allowed increased mentorship by parents for families that need assistance in managing their child as well as the "system".

This spring the complete Vanier team, including the Board had the privilege to attend three interactive sessions with Professor Dr. Nouman Asraf of The University of Toronto. His goal was to demonstrate how we can grow personally and professionally by looking at situations through a different lens. The feedback from those participating was positive and a benefit to their role within Vanier.

The Board has created a committee to provide awareness and process for Equity, Diversity, Belonging and Inclusion for both the Board and the total organization.

The Annual General meeting was held on June 15<sup>th</sup> at Vanier. The May Court Awards were created in honour of the ongoing association and support for Vanier by The May Court Club of London. There are 3 awards, the Champion, the Unsung Hero and Partnership awards. Our president Cathy Egerton presented these awards to the deserving recipients at the meeting.

#### **NUTRITION PROGRAM**

Co-Convenors: Libby McMillan and Caroline Hancock

Yay, a normal school year! Children were in school full time and all activities resumed.

We purchased \$40,000 in gift cards for the school year. Gift cards were distributed to 70 schools, which was up from 60 last year. The price increases in food have likely contributed to the demand for assistance. The outstanding receipts and gift cards have been picked up and applications for the 2023/2024 school year have been delivered.

We investigated Adopting a School. Libby met with the Vice Principal of Lord Elgin to determine if there were ways as a club we could help. In order to have more involvement with the children, which is what the Club seems to want, one of the few options would be to offer a monthly lunch to the School. It would be imperative that we have the members support such an endeavour before we committed to it. We would also need commitment to the funds. The idea is currently on hold.

Many thanks to all who donated to the Nutrition Program this year. Donations this year totalled \$40,352. This represented \$5,252 received from individuals and \$35,100 from other support groups. These support groups included \$12,000 from Forever Legacy Foundation, \$800 from New

St. James Presbyterian Church, \$1,950 from London South Rotary Club, \$1,000 from the Rotary Club of London, Hyde Park, \$3,000 from the Rotary Club of London, \$4,000 from Heeman's Greenhouse Ltd, \$5,000 from the Brenda and Dave Savell Foundation, \$5,000 from Lutheran Social Services, \$350 from Richmond Woods Retirement Home Knitters, as well as \$2,000 in kind from Metro (the gift card discount). In addition to the donations received, the 50/50 Draw has raised \$762 for the Nutrition Program.

As always, we thank our committee members, Ruth Best, Mary Boyle, Jane Davidson, Bonnie Griffiths, Donna Kay, Barbara Loomis, Joan McConnell, and Ginny Tremblay. We greatly appreciate their assistance delivering and picking up gift cards and following up with their assigned schools.

We wish the children a safe, healthy summer and we will start preparing for the next school year in August!

#### GLEN CAIRN COMMUNITY CENTRE GOOD FOOD BOXES

May Court has continued to partner with the Glen Cairn Community Resource Centre (GCCRC) in implementing their Good Food Boxes program. GCCRC serves as the hub for a number of community centers and other organizations in London to receive, pack and distribute generous bags of fresh produce on the last Monday of each month. May Court has steadily continued to provide 3-4 volunteers at the Centre each month throughout 2022 and 2023, including summer months. The need for such bags has grown due to high inflation and general economic conditions. Whereas we were packing approximately 250-300 bags at the start of this service project, the numbers is now often 850-950 bags each month.

However, various health issues and our dwindling club membership have also impacted those available for service projects. We now have only four members who volunteer at Glen Cairn on a regular basis. We will promote the project in the Fall and hope to attract more interest in this very meaningful activity.

#### Y.O.U. LUNCHEON PROGRAM

In the fall of 2021 May Court members started volunteering in the kitchen at the Clark Road residence of Youth Unlimited (Y.O.U.). Helping this organization was a very good fit with that of May Court as we both assist youth at risk. This service option was included on the membership renewal form.

Volunteers assumed shifts on Wednesdays from 11am until approximately 1:30 or 2pm. The duties were not overly strenuous - spooning soup, cutting veggies, serving up plates of food and helping with dishes. The chef there accommodated us as needed. Covid and declining membership has taken its toll and the program has been paused for the time being. We plan to resume again when the opportunity is right and we can once again recruit members to participate.

#### CORE COMMITTEE REPORTS

#### **ARTISANS**

After the easing of Covid restrictions last year, the Artisans have been able to continue their Monday morning meetings. As our group moved closer to the November Marketplace 2022, we continued to work and looked forward to our new venue.

This year has brought us a new member, Anne Pavlosky, whose talents and enthusiasm have quickly made her an integral part of our group.

In the spring the Artisans once again secured the community booth which had been so successful for us at the Western Fair Market for March 25th and 26th. We also offered to share contact information and details of this venue with other May Court groups so they could arrange a booth if they decided to do so. We had many new items and looked forward to their debut. Pictures were posted on Facebook on March 13th and repeated on March 20th. We asked our Members to share them and any future pictures to increase ongoing awareness during the Spring Season!

Once we got the Western Fair event behind us, we focused on preparing for the upcoming Marketplace this Fall. Shopping was done and plans got well underway. We are looking forward to Marketplace 2023.

(Formerly Knit One, Sew Too)

With the easing of COVID restrictions, the preserving group was back in business in 2022. The large workshops were still restricted and members mostly had small groups working together to make the products. We did not participate in the Komoka Marketplace this year.

The cost of all ingredients and supplies continued to increase. Jars were purchased at last year's price which was a savings. However, fabric, sugar, fruit and vegetables, and especially Certo price increases continue to eat into our profit margin. The cost of products remained at \$8.00 a jar, but it will increase in 2023.

We did have a few workshops where the preparation work for salsa, chili sauce, pear chutney and the antipasto was done. People then took the big pots of raw ingredients home to cook and process. It was helpful for the processors!

We made 773 jars of product and went to Marketplace with about 500 jars to sell. Business was brisk and only a few dozen jars were left over. Jack Scott made dozens of wooden cutting and charcuterie boards and some sold at the Marketplace. We also offered maple syrup but it was not a big seller.

In total, May's Pantry contributed \$4,900 to the coffers of the Club.
